Youth & 4-H Report

4-H is still a big focus for our board and making sure that all kids across Alberta showing a Simmental influenced animal received a gift. Finding cost effective but still impactful gifts will continue to be a focus moving forward. We have been working with AFSC to distribute packages to their offices in order to minimize shipping costs but this year we had to hold off due to COVID concerns at the offices. Hopefully in 2021 we will be able to utilize their services again. For the third year we offered the chance to win a blower to any Simmental influenced animal. It had normally been for members that won at their district level nut this year it was opened up to all since so many of the districts didn't have a show. We tried to get as many pictures of the projects as we could to be displayed on our Facebook page for added publicity.

We continued our support of the Jackpot Steer & Heifer show at Farmfair. The support was \$500 for the Champion Simmental animals. We continued our support of Summer Synergy of \$1500 as well.

This was the second year that we had a committee made up of 3 board members hold the Adult Advisor role for the AYCSA. The youth board has been very engaged and the open lines of communication between the 2 boards continues to create positive momentum. The AYCSA was very excited to be moving the show to a bigger venue in Stettler for 2020 and continue to develop the program. Show and Sale Committee Report

2019-20 show and sale season was a success. There was a strong lineup of Simmental Cattle exhibited at the fall shows and the fall sales were successful. The spring bull sales started out as previous years and were very strong, however as we all know things took a bit of a shift in March. With the new restrictions and challenges, the Simmental breeders and sales management teams were truly resilient and wrapped up a very positive spring bull sale season. This past year again saw the CSA "Awards of Excellence" and the two participating shows in Alberta were the Olds Fall Classic and Farmfair International. This award compiles show points from participating shows across Canada to be awarded to a bull and female at the final fall show, Agribition, where the winners are announced. Congratulations to Show Female of the Year, Sunny Valley Payton 77E owned by Ultra Livestock, Fraser Livestock and Mader Ranches.

The Olds fall classic was again held in October with a solid contingent of Simmental entries on display. Congratulations to JM New Trend Cattle of Strathmore for Champion Female and to Harvie Crest Cattle Company of Olds for the Champion Bull.

Farmfair International 2019 saw another strong display of Simmental cattle with over 100 entries in the open show and over 20 entries in the percentage show. These entry numbers were very consistent with the past year and had entries from not only Alberta but other provinces as well. Congratulations once again to JM New Trend Cattle for Champion Female and to JT Livestock of Stettler for the Grand Champion Bull.

To celebrate those in attendance at Farmfair as part of the Simmental events, a pizza party was held back in the barns where we completed our various prize draws and award presentations. 2019 events at Farmfair once again included the Alberta Simmental Breeders Select, which was led by Tracy Kimmel. This was the second year that ticket sales continued into the fall sale season and the Breeders Select draw continued the promotion through the Alberta Simmental weekend in December. The \$10,000 draw was made in Red Deer and the winner was Colt Arnold. Our goal each year is to continue the excitement with the Simmental breed and promotion of these great cattle and those breeders involved. We saw a significant increase in the number of memberships sold and it allowed for many more folks to be involved that may not attend the traditional shows. Each year the show and sale committee work with the membership and with the fellow breed representatives for Farmfair and those within the Northlands organization to improve the quality of Farmfair International with a goal to maximize the experience of the exhibitors and spectators and for the promotion of Simmental genetics.

Unfortunately both Olds Fall Classic and Farmfair International have been cancelled for 2020 and the fall sale season will likely look a bit different then what we have come to expect but we know with the strength of the breed and the resiliency of our breeders that it will be strong and there will be incredible genetics and livestock offered.
